Awards will be given in each of the five divisions: 1st through 3rd place for the greatest number of entrants throughout the series and 1st through 3rd place to the teams with the greatest team points accumulated at the end of this year's ten race schedule (1st place requires 2 teams in the division, 2nd place 4 teams, and 3rd place 6 teams). To be entered in the team competition a team must turn in a team roster by July 8, 2019 along with the appropriate registration fee with each team member to be scored listed with their 2019 WORS SERIES NUMBER on the back side of this form.
